## Third Annual North Texas Ballet Folklorico Contest

**WELCOME** - We at the AT&T Performing Arts Center would like to thank all directors, participants, administrators, and those in support for being a vital part of making this event happen. The coordinators for the event would like to provide helpful information to prepare teams and spectators for the contest.

**GENERAL** - The North Texas Ballet Folklorico Contest consists of dozens of participating schools from across the state of Texas performing traditional ballet folklorico routines in front of a panel of judges. Each performance will receive a rating based off a scoring rubric, and participating schools may receive awards based off their performance ratings.

**GUIDANCE** - We at the AT&T Performing Arts Center are ecstatic to open our doors and host The North Texas Ballet Folklorico Contest. We ask that all directors remind all participants and spectators to demonstrate the most respect for our facilities, staff and volunteers. Please be mindful of noise level, respectful of the space, and courteous to those performing in the theater.

**LIABILITY AND MEDIA RELEASE** — All participants must have a liability and media release form on file before participating. These will be available to download from DanceComp Genie upon registration. Any students under age 18 must also have a parent or guardian sign the liability and media release form. Please bring physical copies of the signed documents with you on the day of the contest, organized in alphabetical order by last name. Participants will not be allowed on stage without these forms if not received at check-in on the day of contest.

**SPECTATORS** – The North Texas Ballet Folklorico Contest is open to the public free of charge. We encourage directors, participants, administrators, and family to support and learn from the performances taking place. Please be considerate of those performing—we ask that all spectators enter in and out of the theater during a transition period between two performances. Spectators may film, however please refrain from flash photography.

**FOOD OPTIONS** – The North Texas Ballet Folklorico Contest will be hosting a food truck and a pre-packaged food and drink concession stand for the duration of the event. Folklorico directors and their teams are encouraged to go out to a local restaurant or one of the food trucks at Klyde Warren Park during the lunch break. Students may also bring their own snacks and/or drinks with them to the Wyly Theatre.

**DRESSING ROOM/HELD SPACE** – An area for teams to 'house' their belongings and change into costumes will be provided. A separate changing area will be available for male participants. <u>Please advise a staff member if a participant needs a dressing room accommodation.</u>

**CONTEST SHIRT & ACCESSORIES** – Contest T-Shirts will be available for \$20. If anybody would like one, just select their shirt size on DanceComp Genie when registering and the fee will be added to your total balance. Shirts will be available to pick up on contest day.


**BUS ACCOMMODATION** – Directors and their teams are to be dropped off at the Dee and Charles Wyly Theater, located at 2400 Flora St. Dallas, TX 75201, upon arrival. Bus drivers then will be given parking directions.

#### SPECTATOR PARKING

Alternative lots are also located within walking distance throughout the Dallas Arts District, as well as a DART station located on Pearl St and a bus stop located on San Jacinto St.



Street parking along Flora St will be extremely limited on the day of the contest as it will be used for bus parking. Additionally, Booker T. Washington High School for the Performing and Visual Arts begins its day at 9:10 a.m. and dismisses at 4:30 p.m. and will cause traffic surrounding AT&T Performing Arts Center. As the Center is located in the Arts District, which is in the heart of downtown Dallas, there will be traffic delays from approximately 8:00 a.m. to 9:30 a.m. and from 4:00 p.m. to 6:00 p.m., give or take. Please plan accordingly and factor in the time it will take to walk from your parking or DART stop to the Wyly.

#### STAGE DIMENSIONS & PERFORMANCE INSTRUCTION

There will be two performance areas this year. All solo and duet routines will take place in the Rehearsal Hall on Level Nine of the Wyly Theatre. All ensembles will perform in the main performance hall, Potter Rose. No school will be scheduled to perform in different spaces at the same time. All performers will be escorted by staff to the performance areas and are to be on deck two entries before their performance. If any group is late for their scheduled performance, we will honor the schedule we have and cannot guarantee that there will be time to reschedule the performance. Solos and Duets will enter through the stage right door, perform, and exit through the stage left door to return to the elevator. Small and Large Ensembles will enter stage right and will exit stage left. Please advise the backstage manager if there are alternate entries for your routine in either space.

#### **CLASSIFICATION**

Teachers must classify their students not only by age group (elementary, middle, and high school), but also by experience level. When registering your routines, please indicate if your students are Non-Varsity or Varsity.

- <u>Non-Varsity</u>: Beginner Beginner/intermediate dance groups or solo dancers who compete with practice attire (all black attire, practice skirts, no folklorico shoes) or costume.
- <u>Varsity</u>: Intermediate Intermediate/advanced dance groups or solo dancers who compete with practice attire (all black attire, practice skirts, no folklorico shoes) or costume.

#### REGISTRATION

Each dancer must be registered separately on DanceComp Genie and manually assigned to each routine. When registering, you must provide us with each dancer's name, date of birth, parent/guardian name, and parent/guardian phone number in case of emergency.

#### **CONTEST RULES**

- For the in-person contest, please upload your music directly into DanceComp Genie once you've registered your routine. Go to your Dashboard, and under your registration information there will be a button that says "Upload Music". Click it and upload your track for each routine as an .mp3 file. You may only use traditional music and tracks should be at least two minutes in length but no longer than four minutes in length.
- For the virtual contest, please upload your video directly into DanceComp Genie once you've registered your routine. Go to your Dashboard and under your registration information there will be a button that says "Upload Video". Click it and upload your video of each routine as an .mp4 or .MOV file. The same music rules apply to both the virtual and in-person contest.
- Limit of four routines maximum per school. No cuadros (vignettes) will be accepted.
- Registration closes at 11:59 p.m. on January 25, 2024, three weeks before contest day. You may not make any changes to your routine after registration closes except to cancel.
- Students are under <u>no circumstances</u> allowed in any areas of the building except for the main lobby, dressing areas, and performance spaces.

#### **CONTEST FEES**

- Solo \$45.00/routine
- Duet \$55.00/routine
- Small Ensemble \$65.00/routine
- Large Ensemble \$75.00/routine

You can pay registration fees with either a credit card or a check. All payments are final and you will not be refunded if you cancel. DanceComp Genie will generate an invoice for your records. ### **AWARDS CEREMONY**

North Dallas Ballet Folklorico contest results will be announced at 6:00 p.m. in the Potter Rose Performance Hall directly following the contest. Students will be given time to return to their dressing areas and change before the ceremony begins. The award ceremony is open to all teams, administrators and spectators.

Judges will not receive school names before or during the contest. Each school will be labeled as "School A", "School B", "School C", etc. This helps to ensure impartial and unbiased judging while still allowing staff to track scores for each school.

#### AWARD DESCRIPTIONS

#### All routines will receive one of the following rankings:

**DIVISION I** – Entries that receive a 'superior' on most judging criteria will receive a division I rating.

**DIVISION II** – Entries that receive an 'excellent' on most judging criteria will receive a division II rating.

**DIVISION III** – Entries that receive a 'developing' on most judging criteria will receive a division III rating.

## Schools will have the opportunity to receive the following awards based on their Division Rankings

**AMALIA HERNANDEZ** – This award goes to schools that have submitted three or more dance pieces, varsity and non-varsity, and have received a superior rating on most criteria.

**SILVIA LOZANO** – This award goes to schools that have submitted three or more dance pieces, varsity and non-varsity, and have received an excellent rating on most criteria.

**ANITA N. MARTINEZ** – This award goes to schools that submitted one or two dances, varsity and non-varsity, and have received an excellent rating on all criteria.

**DIANA ELIZABETH GALLEGO** – This award goes to the school that submitted one or more dances, varsity and non-varsity, and have received a developing rating for most criteria.

**JUDGES AWARDS** – The judges panel will be selecting a Best Solo, Best Duet, Best Small Ensemble, and Best Large Ensemble at the end of the award ceremony.

Only the awards listed above will be announced during the Awards Ceremony. Directors must pick up their score sheets from staff after the Awards Ceremony to see the individual scores for each routine.

Scores for each routine are calculated based on three categories, each with their own criteria. Routines will be judged on Technique & Execution, Use of Space, and Presentation. The score sheets and scoring rubric can be found on the next page.
